AN ACT TO AMEND THE FRIENDLY SOCIETIES ACT (CAP 11.19).

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Assembly of Montserrat and by the Authority of the same as follows—

**1 Short title**

This Act may be cited as the Friendly Societies (Amendment) Act, 2013.

**2 Interpretation**

In this Act—

“**principal Act**” means the Friendly Societies Act (Cap. 11.19).

**3 Section 2 amended**

Section 2 is amended by inserting the following definition in alphabetical order—

“**Registrar**” means the Registrar of Friendly Societies;”

**4 Section 3 amended**

Section 3 of the principal Act is deleted and the following substituted:

**“3. Registrar of Friendly Societies**

The Commissioner of Financial Services is the Registrar of Friendly Societies.”.

**5 Section 78 and 79 amended**

Sections 78 and 79 of the principal Act are amended by deleting “\$96” and substituting “\$500”.

**6 Section 83 amended**

Section 83 of the principal Act is amended by deleting “\$240” and substituting “\$1000”.

**7 Section 84 amended**

Section 84 of the principal Act is amended by deleting “\$96” and substituting “500”.

**8 Section 89 amended**

Section 89 is amended by deleting the words “, and all such fees shall be paid by means of stamps”.

**9 Section 93 repealed**

Section 93 of the Act is repealed.

**1 Regulation 9 amended**

Regulation 9 of the Friendly Societies Regulations (Cap. 11.19) is amended by deleting “\$96” and substituting “\$500”.

**2 Schedule amended**

The Schedule to the Friendly Societies Regulations (Cap. 11.19) is repealed and the following substituted—

10. On hearing and determining of disputes under section 63	\$200
11. Registration of special resolution under section 69	\$25
12. Registration of copy of special resolution as memorandum of association under section 66	\$50
13. Cancelling of registry of society on conversion into a company under section 66	\$100
14. Hearing of application of trustees desiring amalgamation or transfer of engagements under section 65	\$100
15. Registration of dissolution of society and making award under sections 72 and 74	\$150
16. Registry of branch societies under section 14	\$100
17. Acknowledgment of registry of branch society and of amendment of branch rules	\$50
18. Issuing certificate of change of name	\$50
19. Registration of each new trustee or new trustees registered together	\$25
20. For every document required to be authenticated by the Registrar not chargeable with any other fee	\$50
21. For every inspection of any documents relating to one and the same friendly society	\$25
