## Iraq

### Introduction

Council Regulation (EC) 1210/2003 ("the Regulation") imposing financial sanctions
against Iraq have been amended so that an asset freeze no longer applies to the entity
listed in the Annex to this Notice.

### Notice summary (Full details are provided in the Annex to this Notice)

- 2. The following entry has been <u>removed</u> from the consolidated list and is no longer subject to an asset freeze.
  - AMANAT AL-ASIMA (Group ID: 8057)

### Legislative details

- 3. On 3 February 2017 Commission Implementing Regulation (EU) No 2017/184 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L29, 3.2.2017, p.19) by the European Commission.
- 4. The Amending Regulation amended Annex III to the Regulation with effect from 4 February 2017
- 5. The Amending Regulation reflects the decision made on 26 January 2017 by the United Nations Security Council (UNSC) Committee to remove 1 entry from the UN Regime list.
