Introduction

1. Council Regulation (EU) 224/2014 ("the Regulation") imposing financial sanctions with regard to Central African Republic has been amended.

Notice summary (Full details are provided in the Annex to this Notice)

- 2. The following entry has been <u>amended</u> and is still subject to an asset freeze:
 - ABDOULAYE HISSENE (Group ID: 13458)

What you must do

- 3. You must:
 - i. check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
 - ii. freeze such accounts, and other funds or assets;
 - iii. refrain from dealing with the funds or assets or making them available to such persons unless licensed by the Office of Financial Sanctions Implementation (OFSI);
 - iv. report any findings to OFSI, together with any additional information that would facilitate compliance with the Regulation;
 - v. provide any information concerning the frozen assets of designated persons that OFSI may request. Information reported to OFSI may be passed on to other regulatory authorities or law enforcement.

- 4. Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report these details again</u>.
- 5. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

Legislative details

- On 25 May 2017 Council Implementing Regulation (EU) No 2017/890 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L138/3,25.05.2017.p.1) by Council of the European Union.
- 7. The Amending Regulation amended Annex I to the Regulation with effect from 25 May 2017.
- 8. The Amending Regulation reflects the decisions made on 17 May 2017 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 2339 (2017) to add 1 individual to the UN list.
- In accordance with the United Nations and European Union Financial Sanctions
 (Linking) Regulations 2017 made under the Policing and Crime Act 2017, the UK
 enacted this decision on 18 May 2017 and issued Notice_CAR_17052017. This EU
 Amending Notice supersedes that Notice.
