Financial Sanctions Notice

North Korea (Democratic People's Republic of Korea)

Introduction

 Council Regulation (EU) 2017/1509 ("the Regulation") imposing financial sanctions regarding North Korea (Democratic People's Republic of Korea) has been amended.

Notice summary (Full details are provided in the Annex to this Notice)

 16 individuals and 1 entity listed in the annex to this notice have been <u>amended</u> and are still subject to an asset freeze.

What you must do

You must:

- check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
- ii. freeze such accounts, and other funds or economic resources;
- iii. refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by Governor;
- iv. report any findings to the Governor, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons that the Governor may request. Information reported to the Governor may be passed on to other regulatory authorities or law enforcement.

- 4. Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report</u> these details <u>again</u>.
- 5. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

Legislative details

- On 9 January 2018 Council Implementing Regulation (EU) No 2018/12 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 4, 09.1.2018, p.1) by the Council of the European Union.
- The Amending Regulation amended Annex XIII to the Regulation with effect from 9
 January 2018.
- The Amending Regulation reflects the decisions made on 22 December 2017 by the
 United Nations Security Council (UNSC) Committee established pursuant to
 Resolution 2397 (2017) to add 17 entities to the UN Democratic People's
 Republic of North Korea list.
- In accordance with the United Nations and European Union Financial Sanctions (Linking) Regulations 2017 made under the Policing and Crime Act 2017, the UK enacted this decision on 27 December 2017 and issued the following Notice: https://www.gov.uk/government/uploads/system/uploads/attachment_data/file/671007/ UN DPRK.pdf.

This EU Amending Notice supersedes that Notice.
