#### **Financial Sanctions Notice**

## Ukraine (Sovereignty and Territorial Integrity)

#### Introduction

 Council Regulation (EU) 269/2014 ("the Regulation") imposing financial sanctions against Ukraine (Sovereignty and Territorial Integrity) has been amended.

## Notice summary (Full details are provided in the Annex to this Notice)

- The following entry has been <u>added</u> to the consolidated list and is now subject to an asset freeze:
  - OVSYANNIKOV, Dimitry, Vladimirovich (Group ID: 13558)

# What you must do

#### 3. You must:

- check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
- ii. freeze such accounts, and other funds or economic resources;
- refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Governor;
- iv. report any findings to the Governor, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons that the Governor may request. Information reported to the Governor may be passed on to other regulatory authorities or law enforcement.

 Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

# Legislative details

- 5. On 21 November 2017 Council Implementing Regulation (EU) No 2017/2153 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 304, 21.11.2017, p.3) by the Council of the European Union.
- The Amending Regulation amended Annex I to the Regulation with effect from 21 November 2017.
