Introduction

 Council Regulation (EC) 1183/2005 ("the Regulation") imposing financial sanctions with regard to the Democratic Republic of Congo has been amended.

Notice Summary

Identifying information for twenty one individuals and one entity listed in the Annex to this Notice has been amended and are still subject to an asset freeze.

What you must do:

- 3. You must:
- check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
- II. freeze such accounts, and other funds or assets;
- III. refrain from dealing with the funds or assets or making them available to such persons unless licensed by the Governor;
- IV. report any findings to the Governor, together with any additional information that would facilitate compliance with the Regulation;

- V. provide any information concerning the frozen assets of designated persons that the Governor may request. Information reported to the Governor may be passed on to other regulatory authorities or law enforcement.
- 4. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.
- Where a relevant institution has already reported details of accounts, other funds or economic resources held frozen for designated persons, they are not required to report these details again.

Legislative details

- 6. On 07 February 2017 Council Regulation (EU) No 2017/199 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L32, 7.2.2017, p.1) by the Council of the European Union.
- 7. The Amending regulation amends Annex I to the Regulation with effect from 8 February 2017.
- 8. The Amending Regulation reflects the decisions made on 13 and 19 October 2016 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 1533 (2004) to update the identifying information relating to 21 persons and 1 entity subject to restrictive measures.
