General Notice of Renewal of Final Designations

Terrorism and Terrorist Financing

Introduction

1. Two designations have been renewed under the Terrorist Asset-Freezing etc. Act 2010 (TAFE).

The reason for this Notice

2. Her Excellency the Governor, has renewed the final designations of the following entities with effect from Thursday 12 October 2017:
 - Ejército de Liberación Nacional (ELN) (Group ID 7364)
 - Sendero Luminoso (SL) (Group ID: 7440)
3. This means that the entities listed above are therefore designated persons for the purposes TAFE and continue to be subject to the financial sanctions imposed by it.

What you must do:

4. You must:
 - i. check whether you hold any accounts, funds or economic resources for, or provide financial services to, the persons set out in the Annex to this Notice;
 - ii. freeze such accounts or other funds;
 - iii. suspend the provision of any financial services to that person;

- iv. refrain from dealing with such funds or making them available to such persons - unless licensed by the Governor;
 - v. report any findings to the Governor, together with any additional information that would facilitate compliance with TAFSA.
 - vi. provide any information concerning the frozen assets of designated persons that the Governor may request. Information reported to the Governor may be passed on to other regulatory authorities or law enforcement.
5. If you have already reported details of accounts held frozen for designated persons, you are not required to report these details again.
6. Failure to comply with financial sanctions legislation is a criminal offence.

Can I challenge a Designation?

7. If you are the designated person, you may appeal to the Supreme Court, under section 26 of TAFSA, any decision of the Governor to make or vary, or not to vary or revoke, an interim or final designation, or to renew a final designation.
8. If you are the designated person or a person affected by a decision of the Governor (other than decisions to which section 26 applies) you may apply to the Supreme Court, for the decision to be set aside.

10. TAFE implements the terrorist asset freezing requirements of UN Security Council Resolution 1373 (2001) and Council Regulation (EC) No 2580/2001 in the UK.
