Financial Sanctions Notice

ISIL (Da'esh) and AI-Qaida Organisations

Introduction

1. Council Regulation (EC) 881/2002 ("the Regulation") imposing financial sanctions against the ISIL(Da'esh) and AI-Qaida Organisations has been amended

Notice summary (Full details are provided in the Annex to this Notice)

- 2. The following entry hasbeen <u>amended</u> and is still subject to an asset freeze:
 - LOUNICI, Djamel (Group ID: 7997)

What you must do

- 3. Youmust:
 - i. checkwhether youmaintainanyaccountsorholdanyfundsorecononicresources for the persons setoutin theAnnex tothis Notice;
 - ii. freezesuchaccounts, andother fundsorecononicresources;
 - iii. refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensedby the Governor;
 - iv. reportany findings to the Governor, together withanyadditional information thatwould fadlitatecorrpliancewththeRegulation
 - v. provide any information concerning the frozen assets of designated persons that the Governor may request. Information reported to the Governor may be passed on to other regulatory authorities or lawenforcer rent

- Where a relevant institution has <u>already reported</u> details of accounts, other funds or economic resources held frozen for designated persons, <u>they are not required to report these</u> <u>detailsagain</u>.
- 5. Failure to comply with financial sanctions legislation or to seek to circumvent its provisions is a criminal offence.

Legislative details

- On 4 June 2018 Commission Implementing Regulation (EU) No 2018/816 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L137,4.6.2018, p.5) by the European Commission.
- 7. The Amending Regulation amended Annex I to the Regulation with effect from 5 June 2018.
- The Amending Regulation reflects the decisions made on 29 May 2018 by the United Nations Security Council (UNSC) Committee established pursuant to Resolutions 1267 (1999), 1989 (2011) and 2253 (2015) to amendthe identifying information of 1 existing entry.
