Financial Sanctions Notice

South Sudan

Introduction

1. The United Nations Security Council's sanctions list has been updated.

Notice summary (Full details are provided in the Annex to this Notice)

- By virtue of the United Nations and European Union Financial Sanctions (Linking)
 Regulations 2017, the following entries have been <u>added</u> to the consolidated list and are now
 subject to an asset freeze.
 - Malek Reuben Riak RENGU (Group ID: 13698) (the "DP")
 - Paul Malong AWAN (Group ID: 13699) (the "DP")

Legislative Details

- On 13/07/2018, the United Nations Security Council adopted Resolution 2428 (2018) concerning South Sudan, approving the addition of 2 entries to its list of individuals and entities subject to an asset freeze.
- Unless the DP's are listed under EU Regulation 2015/735 by 12/08/2018, the asset freeze will
 cease to apply from 11:59 p.m. on 12/08/2018 until the date upon which the DP's are
 listed by the EU.

What you must do

You must:

- check whether you maintain any accounts or hold any funds or economic resources for the persons set out in the Annex to this Notice;
- ii. freeze such accounts, and other funds or economic resources;
- iii. refrain from dealing with the funds or assets or making them available (directly or indirectly) to such persons unless licensed by the Governor
- iv. report any findings to the Governor, together with any additional information that would facilitate compliance with the Regulation;
- v. provide any information concerning the frozen assets of designated persons that the Governor may request. Information reported to the Governor may be passed on to other regulatory authorities or law enforcement.
- Failure to comply with financial sanctions legislation or seeking to circumvent its provisions is a criminal offence.
