Financial Sanctions Notice

ISIL (Da'esh) and Al-Qaida Organisations

Introduction

 Council Regulation (EU) 881/2002 ("the Regulation") imposing financial sanctions against the ISIL (Da'esh) and Al-Qaida organisations has been amended so that an asset freeze no longer applies to the entity listed in the Annex to this Notice.

Notice summary (Full details are provided in the Annex to this Notice)

- 2. The following entry has been <u>removed</u> from the consolidated list and is no longer subject to an asset freeze.
 - DJAMAT HOUMAT DAAWA SALAFIA (DHDS) (Group ID: 7883)

Legislative details

- On 23 April 2019 Commission Implementing Regulation (EU) 2019/622 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 108, 23.4.2019, p.29) by the European Commission.
- 4. The Amending Regulation amended Annex I to the Regulation with effect from 24 April 2019.
- The Amending Regulation reflects the decisions made on 13 April 2019 by the United Nations Security Council (UNSC) Committee established pursuant to Resolution 1267 (1999), 1989 (2011) and 2253 (2015) to remove 1 entity from the UN ISIL (Da'esh) and Al-Qaida organisations list.

PROCEDURE FOR REMOVING PERSONS FROM THE CONSOLIDATED LIST AND DEFREEZING ASSETS

On receipt of Financial Sanctions notices where an entry has been removed from the consolidated list and is no longer subject to any asset freeze:

"You must immediately on receipt of the Financial Sanction Notice advising of removal of person and/or entity from Consolidated List -

- Check whether you have frozen the assets of any person or entity removed from the Consolidated List and verify that the person or entity is no longer subject to an asset freeze.
- ii) Remove the person or entity from your institution's list of persons/entities subject to **Financial Sanction**;
- iii) De-freeze the assets of the person or entity and where necessary re-activate all relevant accounts;
- ii) Send advice to person or entity that the assets are no longer subject to an asset freeze; and
- iv) Advise the Financial Services Commission of the actions taken.

Where the funds or other assets of the person or entity are inadvertently affected by a freezing mechanism upon verification that the person or entity is not a designated person, take all necessary measures to carry out the instructions (ii) to (iv) above.
