## General Notice of Renewal of Final Designations

### **Terrorism and Terrorist Financing**

#### Introduction

 Two designations have been renewed under the Terrorist Asset-Freezing etc. Act 2010 (TAFA).

#### The reason for this Notice

- The Office of Financial Sanction Implementation (OFSI), part of HM Treasury, has renewed the final designation of the following entities with effect from Monday 16 September 2019:
  - Ejército de Liberación Nacional (ELN) (Group ID: 7364)
  - Sendero Luminoso (SL) (Group ID: 7440)
- This means that the entities listed above are therefore designated persons for the purposes of TAFA and continue to be subject to the financial sanctions imposed by it.

#### What you must do:

#### 4. You must:

- check whether you hold any accounts, funds or economic resources for, or provide financial services to, the persons set out in the Annex to this Notice;
- ii. freeze such accounts or other funds;
- iii. suspend the provision of any financial services to that person;
- refrain from dealing with such funds or making them available to such persons unless licensed by the Governor;
- report any findings to the Governor, together with any additional information that would facilitate compliance with TAFA.

- vi. provide any information concerning the frozen assets of designated persons that the Governor may request. Information reported to the Governor may be passed on to other regulatory authorities or law enforcement.
- 5. If you have <u>already reported</u> details of accounts held frozen for designated persons, you are not required to report these details again.
- 6. Failure to comply with financial sanctions legislation is a criminal offence.
- 7. Some dealings with funds and economic resources that would otherwise contravene TAFA can be licensed by OFSI. #### Can I challenge a Designation?

- 8. If you are the designated person, you may appeal to the Supreme Court, the Court of Session, under section 26 of TAFA, any decision of Governor to make or vary, or not to vary or revoke, an interim or final designation, or to renew a final designation.
- 9. If you are the designated person or a person affected by a decision of the Governor (other than decisions to which section 26 applies) you may apply to the Supreme Court, for the decision to be set aside;

- 11. TAFA implements the terrorist asset freezing requirements of UN Security Council Resolution 1373 (2001) and Council Regulation (EC) No 2580/2001 in the UK.
